Standard incentives make it easy to save

• Premium natural gas heating: high-efficiency unit heaters, condensing furnaces, direct-fired radiant heating, condensing boilers, boiler vent dampers and steam traps.

- Building envelope upgrades: attic, roof, wall and pipe insulation for existing buildings. Existing multifamily property upgrades include windows, exterior doors and duct insulation.
- Hot water efficiency: high-efficiency tank and tankless water heaters, commercial clothes washers, ozone laundry systems, showerheads, showerwands, bathroom and kitchen faucet aerators, commercial dishwashers, as well as in-unit clothes washers and dishwashers for multifamily properties.
- Gas-fired foodservice equipment that is ENERGY STAR® qualified: griddles, convection ovens, frvers, steam cookers and dishwashers.

Custom incentives offer flexibility for new and existing buildings

In addition to our standard offerings, custom incentives may be available for investments including heating, ventilation and air conditioning controls, HVAC; variable frequency drives, VFDs; energy recovery systems and specialized premium-efficiency equipment. For an existing commercial building, these projects must be pre-approved and often involve a technical study, provided at no charge. We work with you through each step of the process.

Do you have a sophisticated controls system but uncomfortable tenants, staff or occupants? If you have pneumatic controls, we can evaluate whether you'll benefit from installing a new DDC system.

Services and incentives enhance new construction and renovation

We provide financial support for the professional services necessary to design and construct energy-efficient commercial buildings.
