| Ductless heat pump for homes replacing electric resistance heat in a primary living space, HSPF2 8.55 or greater | \$1,800 |

| Heat pump controls for homes heated primarily by an electric heat pump with electric furnace backup | \$250 |
| High-efficiency gas furnace with a 95% AFUE or greater | \$1,600 |

HOW TO PARTICIPATE

Establish your eligibility

To qualify for Savings Within Reach, you must live in a single-family home, manufactured home or multifamily residence that is an attached side-by-side unit like a rowhome, or is a unit within a duplex, triplex or fourplex. Stacked structures with five or more units are eligible for the ductless heat pump upgrade only. Oregon residents must live in homes heated by Portland General Electric, Pacific Power, NW Natural, Cascade Natural Gas or Avista. Washington residents must reside in Clark, Klickitat or Skamania County, and your home must be heated with gas by NW Natural.

We will provide you with a selection of specially trained trade ally contractors in your area, or you can view a list of participating contractors at **www.energytrust.org/find-a-contractor**.

Please note: If you live in a rental property, the homeowner or property owner must approve work before it begins. Manufactured homes with land ownership are also eligible.

Install energy-efficient home improvements

Prior to beginning improvements, your contractor will ask you to sign an Income Verification form to confirm your eligibility. All improvements must be installed by an approved Savings Within Reach participating contractor.

Sign the incentive application and pay your invoice

After installation, your contractor will submit your paperwork and the invoices for your improvements to Energy Trust. Incentive amounts must not exceed the cost of your improvement project.

Your Energy Trust incentive will be paid directly to your contractor, who will deduct the incentive amount from your invoice, reducing your out-of-pocket expense. You are required to pay the balance of the invoice.

Incentives are subject to funding availability and may change. Special qualifications and restrictions may apply.

OTHER OPPORTUNITIES

- If you are interested in rooftop solar for your home, Energy Trust offers increased cash incentives for Savings Within Reach-qualified households through Solar Within Reach. For more information, call 1.866.368.7878.
- If your income is below the minimum Savings Within Reach income range, you may be better served by Oregon's Weatherization Assistance Program, administered by Oregon Housing and Community Services.
