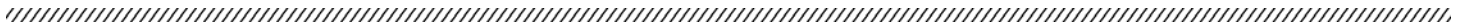


Solar Ready Checklist

Need-to-know information:

- Checklist is based on Energy Trust Solar Ready Installation Requirements. All requirements must be met for incentive payment.
- Trade ally builder to notify the EPS New Construction program of intent to install solar ready infrastructure on multiple sites within one development.
- If a W-9 is required the payment will be made to the name on the W-9.
- Please allow up to 60 days for incentive processing after completed application and supporting documents are received.
- Home must be pursuing EPS through EPS New Construction program.

Terms and Conditions

APPLICATION: All incentive applications must be filled out completely, truthfully, and accurately. Verifier (the “Applicant”) is advised to retain a copy of all applications and any accompanying documentation submitted to Energy Trust under this program. Energy Trust will not be responsible for lost documentation. Incentives are available for work performed, after January 1, 2018 and on or before December 31, 2018 and must be submitted within 90 days of the date of install. Fund for the incentives are limited and available on a first-come first-serve basis.

ELIGIBILITY: Incentives are available to Energy Trust trade allies performing work on homes receiving electric service from Portland General Electric or Pacific Power. The project must also be applying for an EPS. Incentives for solar ready measures are available only to qualified solar ready trade allies.

VERIFICATION: All required information must be filled out in its entirety as required by the program. Should an Applicant’s site be chosen for a post-construction quality assurance review, satisfactory completion of that review must occur before payment. This review is for the purpose of verifying information before incentive payment only. No warranty is implied by reason of a participation in this program or by reason of any review by the Energy Trust EPS New Construction program.

PAYMENT: The Incentives will be promptly paid on (i) installation of the solar ready measure(s), (ii) verification of the measure(s), (iii) submission and approval of this completed Incentive Application, and (iv) W-9. Payments will be made to the Applicant. Please allow up to 60 days for receipt of payment.

INCENTIVE AMOUNT: Incentives are limited to the reimbursement of installation of solar ready measures as set forth in this Application. Details of this program, including incentive amounts, are subject to change without prior notice.

ELIGIBLE EQUIPMENT: To be eligible for the incentive, home must meet the criteria indicated on the incentive application form.

INFORMATION RELEASE: The Applicant understands and agrees that Energy Trust and/or its representatives may include a description of this application, including the Applicant’s name, the Applicant’s company name, services provided, project cost or energy savings, in reports, studies, and other documentation required by Energy Trust, its Board of Directors, the Oregon Public Utility Commission, Oregon Department of Energy, Oregon Housing & Community Services, and the Oregon Legislature. Energy Trust will treat all other information gathered as confidential and report it only in the aggregate.

TAX LIABILITY: Energy Trust is not responsible for any tax liability, which may be imposed on the Applicant as a result of payment of any incentives or as a result of obtaining financing. Energy Trust is not providing tax advice, and any communication by Energy Trust is not intended or written to be used, and cannot be used, for the purpose of avoiding penalties under the Internal Revenue Code.
