Receive **up to \$16,000 from Energy Trust of Oregon, plus additional funding** through our partner agencies to bring your new home into reach. Your navigator will help you secure available funds and review your options so you can select the home and vendors that work best for you.

HERE'S HOW IT WORKS:

- 1 Talk with a program navigator**
Energy Trust will confirm eligibility, review the general time and cost of the project and discuss available funding and resources.
- 2 Envision your project**
Visit retailers to get a sense of your wants and needs, and request cost estimates.
- 3 Reserve your grant funding**
Energy Trust and other partners will reserve your funding and provide a letter of commitment to help you complete your financial package. Partner agencies offering financial assistance include Oregon Housing and Community Services: www.oregon.gov/ohcs/mmcrc.
- 4 Select a lender**
If additional funding is needed for your project, complete a loan application with a lender of your choice. Your lender will request project estimates and your funding letter of commitment.
- 5 Plan your project**
Secure a written bid that includes your new home, the cost of removing your old home and all other project costs. Your navigator will provide support.
- 6 Secure loan approval and sign your contract**
Submit bids and documents to your lender and secure your final loan approval. Your loan will be able to close after your home purchase contract and scope of work are signed. Then, sign your purchase agreement for a new home. Your lender, Energy Trust and other funders will manage down payments to vendors for you.
- 7 Manage the project**
Maintain communication with your vendors. They may provide updates on timing and request information.
- 8 Move in!**
Work with Energy Trust to complete your final inspection and interview. The final loan disbursements will be paid to contractors. Move in and enjoy your new, energy-efficient home.



ELIGIBILITY AND FUNDING

To be eligible for funding, your:

- Current home must have been constructed prior to 1995
- Primary heating fuel source must be electric or gas and provided by a participating utility
- Home must be located in a community with affordability guidelines or your household income must meet Savings Within Reach guidelines: www.energytrust.org/income-eligibility.
